Change Leadership to Build a Culture of Health

- Builds on RWJF's 40-year legacy of investing in leaders in health and health care

Health Policy Research Scholars

Preparing Doctoral Scholars as Leaders

- Five-year program
- First- or second-year doctoral scholars, research focused
- Building equity by investing in scholars from underrepresented populations or disadvantaged backgrounds (race or ethnicity, socioeconomic status, or similar factors)
- Program elements:
 - Leadership training
 - Curriculum: health policy, health equity, population health
 - Interdisciplinary collaboration with leaders from various fields
 - Dissertation support and mentorship
 - Collaboration with participants in all four programs and RWJF



Dedicated Cohort, Robust Support

- Up to 50 participants each year
- Health policy-related research interest
- Enrolled full time in U.S. institution
 - Complete program from home institution—no relocation
- Support
 - \$30,000 annual stipend up to four years
 - Competitive dissertation grant up to \$10,000








Purpose

The goal of *Health Policy Research Scholars* is to create a large cadre of diverse doctoral students from multiple (nonclinical, research-focused) disciplines—students whose research, connections, and leadership will inform and influence policy toward a Culture of Health. Specifically, we aim to recruit doctoral students from a variety of social sciences (e.g., urban planning, health, economics, ethnography, education, social work, etc.) who are training to be researchers. For the 2016 cohort, the *Health Policy Research Scholars* program will enroll up to 50 scholars who are interested in health policy research and from underrepresented populations and/or disadvantaged backgrounds. Examples of eligible individuals include, but are not limited to, first-generation college graduates, individuals from lower socioeconomic backgrounds, individuals from racial and ethnic groups underrepresented in doctoral programs, and individuals with disabilities. *Health Policy Research Scholars* will be completed concurrently with the doctoral program and is designed to enhance and enrich the doctoral program. *For more information, see the full Call for Applications*.

The COH Action Areas are:

- Making Health a Shared Value, measured by indicators such as the percentage of people who strongly agree
 that health is influenced by their peers and their communities and the percentage who indicate they have
 adequate social support from family and friends.
- Fostering Cross-Sector Collaboration to Improve Well-Being, denoted by measures like the number of local health departments that collaborate with community institutions and employers who promote better health in the workplace.
- Creating Healthier, More Equitable Communities, using measurements such as the number of grocery stores, farmers' markets, and safe sidewalks in communities; the ratio of children attending preschool; and the affordability of housing.
- 4. Strengthening Integration of Health Services and Systems, gauged by measures such as the percentage of people served by a comprehensive public health system and the percentage of physicians sharing electronic data with other clinicians, health systems and patients.
