

**Thank you for agreeing to share your story with the Robert Wood Johnson Foundation.**

The background, experiences and opinions you share with us are important contributions to the story bank that we use to help explain and advance our vision for a Culture of Health. We use story bank content on our website, in other materials, in articles, speeches and other public appearances. We simply cannot Build a Culture of Health without stories like yours!

In order to make sure we can use your story, we ask that you sign the following release for your own story or the story of your child (if he or she is under 18):

I irrevocably agree that:

**1. I give the Foundation permission to photograph and record me and to use the narrative I provide, including my words and the details of my background and life experiences, insights and opinions (hereinafter, “my image, my voice, my words and my story” ) to advance the charitable goals of the Robert Wood Johnson Foundation**

- I give the Robert Wood Johnson Foundation and its agents, co-funders, contractors, employees, grantees, and Trustees (collectively, “RWJF”) permission to photograph and record me and document my story. RWJF may use my image, my voice, my words and my story.
- I give RWJF permission to use my image, my voice, my words and my story, in whole or in part, and with or without my name, in publications, presentations, websites, social media services, or any other types of communications to advance the Foundation’s charitable goals, which include, but are not limited to, education, training, research, public relations, marketing, and use by or for the news media.
- I also give RWJF permission to use my name, image, or other information about me for communications related to the photographs, recordings, and materials that may be created from them.

**2. I shall have no rights in the photographs, recordings, writings or materials that may be created from them, even though those materials may feature my image, my voice, my words and my story.**

- I will not have the right to inspect or approve the use of the photographs, recordings, writings, speeches or other materials that may be created from them, now or in the future.

**3. I acknowledge and understand that I will not be paid or receive other remuneration for RWJF’s use of my image, my voice, my words and my story and that I may not use my story bank participation to imply RWJF endorsement or funding of me, my work or organizations with which I am affiliated.**

**4. I acknowledge and understand that RWJF is not required to use my image, my voice, my words and my story and that use of my contributions to the story bank shall be in RWJF's sole discretion.**

**5. I have no legal claims against you or third parties related to the photographs, recordings, writings, speeches or materials that may be created from them.**

- I understand and agree that, by signing this consent, I release any and all legal claims (including, but not limited to, claims based upon copyright, invasion of privacy, defamation, or right of publicity) related to the use of the photographs, recordings, writings or other materials that may be created from them. This means that I, my family members, and my heirs have no legal claims against the Foundation arising from any use, editing, publication, distribution, or republication of the photographs, recordings, or materials that may be created from them.

I represent that I am 18 years of age or older and that I understand and agree to the terms set forth above.
