THE FUNDING OPPORTUNITY¹

- Community Solutions for Health Equity (CSHE) is a program of the Robert Wood
 Johnson Foundation (RWJF) launched in the summer of 2019. CSHE is a growing
 collaborative partnership between community-based organizations across the United
 States who are working to mitigate healthcare systems barriers and practices that
 perpetuate health inequities in their local communities.
- The CSHE program works to uplift community histories, viable solutions, and cultural priorities around wellbeing and health justice to inform the conditions changes that are necessary for healthcare systems transformation.
- CSHE accomplishes this work through intentional partnership building and the codevelopment of effective strategies that build upon existing leadership, community engagement, and cultural knowledge systems.
- The program is guided by a co-created <u>theory of change</u>, which emphasizes community agency over institutional decisions and community's own care; collaboration that invites multiple perspectives to the table to build solutions together; processes, structures, and engagement that acknowledge and repair the harm caused by the healthcare system; and amplifying the needs and strengths of patients.
- This program focuses on changing local healthcare system policy and practice (the
 regulations and procedures that healthcare systems set up for providing care or
 structuring their work), not government policy (actions and programs a state or local
 government implements to address community needs).
- Funded partners participating in the program are supported by the CSHE national program office (NPO), the Cultural Wellness Center. The Cultural Wellness Center is a non-profit organization with 27 years' experience in deep community engagement with members of communities of all ages in the restoration of cultural knowledge of origin. The Cultural Wellness Center mission is to unleash the power of people to heal themselves and build community.

The national program office will provide access to transformational technical assistance. Funded partners will continue to participate in strategy and information-sharing activities organized by the national program office, including conference calls, in-person meetings, conferences, and

webinars. Funded partners will also engage in national communications efforts led by the NPO to bring attention to health equity.

FUNDING DETAILS

- Type of Award: Awards funded under this opportunity will be structured as grants.
- Number of Awards: Up to 11 awards will be funded.
- Amount of Award: Each award will be up to \$300,000.
- Award Duration: Awards will be for 2 years.
- Use of Funds: Award funds should cover actual costs of the project including personnel
 and other direct costs. If the grantee is a public charity, grant funds will also cover
 indirect costs to support the applicant organization's general operations. In keeping with
 RWJF policy, funds may not be used to support clinical trials of unapproved drugs or
 devices, to construct or renovate facilities, and for lobbying or political activities.
 Additional budget guidelines are provided in the online application materials.
- **Payment of Awards:** Payment of the award generally will be based upon spending against approved budgets or milestones (not invoices).

OPEN ACCESS

In order to ensure RWJF-supported research is made accessible to a wide and diverse audience, awardees who publish findings in peer-reviewed publications must do so in open access journals and/or must include funds in their budgets to cover the cost of making the resulting publications open access (typically \$2,000–\$5,000 per manuscript). See our <u>Open Access policy</u> for more information.

SELECTION CRITERIA

This request for proposals is open only to existing funded partners who are participating in the CSHE program. Funded partners may, but are not required to, include additional collaborators in their grant proposal who did not participate in the program previously. Funded partners may make a change in fiscal sponsorship and still be eligible to receive grant funding. We expect to fund grants that:

- Align with the co-created <u>theory of change</u> in terms of outcomes and activities
- Build on lessons learned from the first phase of CSHE; and
- Include deep community engagement and community leadership

EVALUATION AND MONITORING

An independent research group selected and funded by RWJF will conduct an evaluation of the program. As a condition of accepting RWJF funds, we require awardees to participate in the evaluation.

Proposals for this program must be submitted via the RWJF online system. You will receive an email invitation with a link to the RWJF online system and additional instructions. To begin your proposal, select the link in the email and follow the instructions.

Proposal Narrative

Within the online system, applicants will be asked to submit a proposal narrative.

Please note you will be asked to upload your proposal narrative as a PDF to the Project Proposal Narrative section of the online system. The proposal narrative cannot exceed 12 pages. Please use Arial font at size 11 with line spacing at 1.5.

The proposal narrative should contain the following information:

<u>CSHE 1.0 PROJECT OVERVIEW</u>: Please write a one page summary to capture your experiences with CSHE 1.0; please use the guiding questions below to complete your capture:

- 1. Reflecting on the past three years with the CSHE program, how would you describe the approach(es) your organization has used to build this project around healthcare systems transformation?
- 2. How has your experience in building the CSHE program supported and/or challenged your overall organization's work?
- 3. Provide your CSHE project's major milestones. These could include but is not limited to: healthcare system engagement, community engagement, program staffing, communications, or other milestones in the first three years.

CSHE 2.0 PROPOSED PROJECT PLAN:

1. Objectives

State the principal objectives for your project for CSHE 2.0.

2. Activities and Deliverables

 Describe your project's approach for the next two years, along with its main activities and related components.

3. Outcomes

- Describe your communications plan for advancing the project's objectives for CSHE 2.0.
- Name the target audiences (e.g. community, hospital chief financial officers), the messages you expect to deliver to each audience, and what platforms or strategies will be used to deliver these messages to each audience.

5. Staffing

- Identify the principal project's staff you will need for CSHE 2.0 and the responsibilities of each staff.
- Identify any key partners, consultants and collaborators (if any) necessary to achieve the project's objectives and how they will support the project.

6. Timeline

- In the Supporting Documents section of the proposal, provide an estimated timeline for the project's major milestones, including communications milestones, for CSHE 2.0. Please use your best judgment when projecting the project's timeline. This will not be part of the 12-page proposal narrative. A timeline should be included in the Supporting Documents section of the online application.
 - It is possible to request a no-cost extension if unforeseen circumstances cause a delay or pivot from the original timeline. We know that you will make every effort to meet the project milestones to the best of your abilities

All proposals for this solicitation must be submitted via the RWJF online system. You will receive an email invitation from <u>my.rwjf.org</u> with instructions and a link to the RWJF online proposal system. To begin your proposal, select the link in the email and follow the instructions.

All applicants should log in to the system and familiarize themselves with online proposal requirements well before the final submission deadline. Please note that, in the 24-hour period leading up to the proposal deadline, staff may not be able to assist all applicants with any system-related issues. Therefore, we encourage you to submit your proposal well before the deadline so that any unforeseen difficulties or technical problems may be addressed in advance.

EVALUATION

The purpose of evaluation at RWJF is learning rather than accountability. An independent research group selected and funded by RWJF will conduct an evaluation of the funded project. RWJF intends for this project to contribute to national efforts to transform healthcare. Therefore, the program will publicly release results from this evaluation. The evaluation team will follow principles of equitable evaluation, and study how inclusive, collaborative, community-led efforts can contribute to healthcare system transformation. As a condition of accepting RWJF funds, award recipients must participate in the evaluation. Participation includes assisting with necessary data collection to accomplish the evaluation objectives. These data collection efforts may include interviews or focus groups and reviewing existing written materials.

MONITORING

RWJF monitors the awardees' efforts and careful stewardship of funds to assure accountability. Awardees will be required to submit periodic narrative and financial reports.
